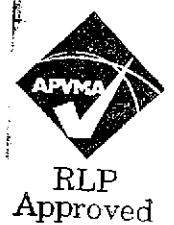

Mushroom Trays and Beds	Control of the adhesion and penetration of mushroom mycelium in timber trays to facilitate the removal of the adherent compost	Normal dilution level: 6 ml EuroChem® EZY-TIP Fungicide per Litre of water (to achieve a concentration of 1500 ppm)
CRITICAL COMMENTS		
The treatment should be done on well cleaned trays to ensure the appropriate fungicide residue is on the wood surface. The treatment is not an alternative to heat sterilisation (COOK-OUT). In a strict sanitation programme both practices should be carried out where possible.

GENERAL INSTRUCTIONS**MIXING**

- **Dipping-application:** Fill the dipping tank with water up to 70% of the total required volume. Add the appropriate amount of EuroChem® EZY-TIP Fungicide. Add water up to 100% of the required volume.
- **Spray-application:** Fill the spray tank with water up to 70% of the total required volume. Add the appropriate amount of EuroChem® EZY-TIP Fungicide. Stir gently and add water up to the required volume. Addition of an antifoam agent might be required to avoid excessive foaming.

APPLICATION

- **Dipping:** Immerse the trays 30-60 seconds in the treatment solution. Allow the trays to drip off and let them dry in a sheltered well-ventilated place.
- **Spraying:** Apply the solution with a large droplet sprayer on the internal surface of the trays. Make sure that all corners are well treated. Apply to run-off. Let the trays dry in a sheltered well-ventilated place.

Some naturally occurring fungal populations resistant to EuroChem® EZY-TIP Fungicide and other Group 3 fungicides may exist through normal genetic variability in any fungal population. These resistant individuals can eventually dominate the fungi population if these fungicides are used repeatedly. These resistant fungi will not be controlled by EuroChem® EZY-TIP Fungicide and other Group 3 fungicides, thus resulting in a reduction in efficacy and possible yield loss. Since the occurrence of resistant fungi is difficult to detect prior to use, TGAC Australia Pty Ltd accepts no liability for any losses that may result from the failure of EuroChem® EZY-TIP Fungicide to control resistant fungi. To avoid build up of resistant strains, label recommendations should be followed and a strict sanitation programme should be carried out throughout the season.

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging for appropriate disposal to an approved waste management

facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.
