DIRECTIONS FOR USE

SOIL WETTER Pro is best applied in cool conditions preferably before rain or irrigation. Avoid direct contact with sensitive vegetation as burning may occur. **SOIL WETTER Pro** should be used at a dilution rate of 500mL per 100L of water. Do not exceed 1L/100L of water. When using **SOIL WETTER Pro** in a new situation or on sensitive crops, test crop sensitivity by application to a small area prior to wide scale use.

GENERAL INSTRUCTIONS

MIXING

1. Half fill tank with water

2. Add SOIL WETTER Pro and mix thoroughly.

3. Add remaining water

CAUTION: Foaming may occur.

Avoid excessive aeration of spray tank

COMPATIBILITY

SOIL WETTER Pro is preferably applied alone. If mixing with other products a jar test is recommended or consult your reseller or RONIC International for specific instructions.

SPILLAGE

In the event of spillage absorb onto sand or chemical absorbent. Remove residue with detergent and hot water. Dispose of by normal waste disposal methods conforming to local authority codes.

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL

If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.
